



#### 1 Introduction

#### 1.1 Objectives

Demonstrate that the end-of-FY2020 capabilities of the Rubin Science Platform have been made available on the Interim Data Facility, and that DP0.1, based on ingested externally-provided DC2 data, can be supported. May be demonstrated with the DC2 DP0.1 dataset itself or with a dataset of equivalent complexity.

DP0.1 expectations are as described in RTN-001 and RTN-004.

- DMS-LSP-REQ-0014 (Download Data) Only verified as far as downloading a tabular data result from the Portal Aspect is concerned. Downloading data from the Notebook Aspect should also be checked, and downloading data, regardless of Aspect, from the User File Workspace and User Database Workspace, should also be checked.
- DMS-PRTL-REQ-0076 (Image Plot Overlays) Verified for astrophysical coordinates in both direct Portal usage and in Portal-used-from-Notebook visualization. Not verified

- DMS-PRTL-REQ-0090 (Simple Filtering of Tabular Data) Partially covered by the basic tests done, but should be subjected to a test more focused on this particular behavior.
- DMS-PRTL-REQ-0092 (Filtering of Tabular Data by Multiple Columns) Partially covered by the basic tests done, but should be subjected to a test more focused on this particular behavior.
- DMS-PRTL-REQ-0095 (Saving Displayed Tabular Data) Partially covered by this test case. More comprehensively covered previously by LDM-503-10a (LVV-C85) and ready for review based on that.
- DMS-PRTL-REQ-0107 (Data Selection from a Plot or Image) Verified but only for rectangular selections, not arbitrary polygons.

The following requirements were not found to be fully satisfied by this test case at this time, and will need re-verification at a future date:

 DMS-LSP-REQ-0017 (Tabular Data Download File Formats) - Only checked against Portal Aspect table downloads; in this usage, no option for FITS binary table download was presented (except as the payload of a VOTable with FITS as its internal format). Not checked for direct API Aspect (i.e., TAP) access.

- DM-31999 Fix nested utility test cases with explicit references to the NCSA RSP
- DM-32000 Firefly: incorrect double-click for negative floating-point numbers
- DM-32001 Investigate VOTable output format versions available in Firefly
